


WHEREAS:

3) i) Understanding is valid up to 2026 the availability / continuation of Skill Training under Citi Bank Pathway To Progress CSR Initiatives.

4) GENERAL TERMS & CONDITION

- i) That the candidate is required to submit his /her Aadhhar card, Photo, Last Educational Qualification Documents at the time of Enrollment.
